The discussion included the RD and DTR career pathways to various levels of expertise. The initial level is the Novice phase which is the Coordinated Program or Didactic Educational Program for RDs and the Dietetic Technician Program for the DTR pathway. The levels advance through the Beginner phase (e.g., internship), Competent phase (first three years of practice after registration), Proficient phase (more advanced operational skills, possible specialty credentials), Advanced practice phase, and Expert phase.

Anna Marie Moser Celebrates 50 Years of Membership with the Academy of Nutrition and Dietetics

Work History: In 1953 I graduated from St. Mary's Academy in O'Neill, Nebr- and at that time had joined the Sisters of St. Francis in Denver- then attended Regis College for a couple years. From there I went to work on the Pineridge Indian reservation in South Dakota for a while, then on to some hands on experience working in the hospital kitchen in Alliance. Nebraska. In 1958-59 I headed to St Mary College in Leavenworth, Kansas where I received my BS in Nutrition finishing in May of 1961. From there on to St. Mary's in Rochester, Minn for my internship finishing that with honors.

In July of 1962 I started my dietetic work at the then St Mary Hospital in Scottsbluff, Nebr where I worked until 1972 when I left the convent. During my time in Scottsbluff I consulted with several hospitals and a nursing home, taught Practical Nurses. While there the Meals on Wheels program was started- and actually several ladies from Casper came to visit us and then started the program here.

In May of 1972 I made the move to Casper and started working at Wyoming Medical Center as Production Dietitian which I did until 1992 changing to the Clinical position which I've done since that time. This was a wonderful move and has been most rewarding. During this time I've met so many wonderful people from around the state.

From 1972- 1979 I did continue to do some consulting work here in Wyoming. It was during this time that I served as WDA Secretary, Treasurer, Vice-president and President being President in 1978-79 I believe. The highlight of my work experience was receiving the 2005 WDA Outstanding Dietitian Award and in 2008 the WMC Health Care Professional Award for Outstanding Practice.

In closing I would say doing what I still really enjoy doing has been most rewarding and to all of you thank you for your help along the way and for your friendship through the years.

In Memory of Margaret S. Boyd

Margaret S. Boyd, 83, Laramie, died Wednesday, April 11, 2012, at her home. She was born June 20, 1928, in Greeley, Colo.

After graduating from Greeley High School, she earned a bachelor's degree at Colorado State University with a major in food and nutrition. Following a one year dietetic internship at Grasslands Hospital in Valhalla, N.Y. and four years as clinical dietitian at Denver Presbyterian Hospital, she returned to Colorado A & M and obtained a Master of Science degree in dietetics in 1956. She joined the University of Wyoming faculty that year and taught undergraduate and graduate courses in food and nutrition until retiring as Professor Emeritus in 1984. During this interval she supervised graduate student research and coordinated the dietetic internship program.

For 10 of these years, she was head of the Home Economics Department (now Family and Consumer Sciences). She was the Mortar Board Outstanding Woman Faculty Member for 1970 and co-recipient of the University of Wyoming Award of Merit in 1993.

Throughout her professional career, she was active at both national and state levels in the American Dietetic Association Her collaboration with colleagues in the Wyoming Extension Service resulted in publication of the book "Baking at High Altitude."

After she retired, she maintained her membership in ADA and continued educating students. Despite ill health, Margaret maintained a bulletin board with nutritional information in the Family and Consumer sciences department at UW. She supported WDA by contributing to various causes and setting up a scholarship for dietetic students.
